How well are European (and the Portuguese) health systems attaining equity goals? Findings from three empirical studies

Under the framework proposed by WHO (2000) to assess health systems, the distribution of health in the population and the distribution of financial contribution are key features to evaluate their attainment. Despite considerable attention to the problem of health inequalities since the 1980s, striking differences in health persist in Europe as well as barriers in access to health care. Although access depends on multiple causes, financing plays a relevant role in this regard and when contributions are unfairly distributed they might result in increased risk of unmet health care needs or in increased risk of catastrophic payments and impoverishment. These in turn can further deepen inequalities in health.

In this conference, three studies related with the areas above will be presented. One study uses data from the European Social Survey 2014 and aims to identify determinants of unmet needs at the European level, with a particular emphasis on the impact of social capital.

Because Portugal was severely hit by the economic and public debt crisis, while remaining one the European countries with highest shares of out-of-pocket payments in total health expenditure (this share is similar to that of Hungary), there are concerns over the deterioration of equity indicators. Thus, one study draws upon data taken from three waves of the Portuguese Household Budget Survey, analysing the evolution of catastrophic health expenditure in a decade, since 2005. The other study focuses on inequalities in health, specifically, for the case of adult obesity, using data from the Portuguese National Health Survey 2014.

Carlota Quintal, PhD



Carlota Quintal is an Auxiliary Professor at the Faculty of Economics, University of Coimbra, Portugal. She completed her PhD (in Economics) at the University of York (UK) and her undergraduate studies at the University of Coimbra. Currently teaches health economics (graduation and master), macroeconomics and microeconomics. Her research interests lie in the area of health economics with particular focus on equity in utilisation and finance of health care. She is author/co-author in articles published in international and national scientific indexed and refereed journals such as *Health Economics, Policy and Law*; *Health Policy*; *Applied Health Economics and Health Policy*; *Public Health*; *International Journal of Social Economics*; *Utilities Policy*; *Water Policy*; and *Portuguese Journal of Public Health*. She has participated in projects funded by the European Commission, the Portuguese Foundation for Science and Technology and Foundation Calouste Gulbenkian. She has been member of scientific committees of national (APES) and international (ECHE, iHEA) conferences and has been referee for several scientific journals such as *Health Policy* and *Social Science & Medicine*. She has participated as presenter and/or co-author of presentations in relevant conferences of health economics.
