Professor Milena Pavlova

Milena Pavlova received an MSc in Computer Sciences from the Technical University of Varna in 1995, an MPH in Public Health from Maastricht University in 1997 and a PhD in Health Economics from that same University in 2002. Since 2014, she is an Associate Professor of Health Economics at the Department of Health Services Research – Research School CAPHRI, Maastricht University.



She has been involved in teaching at different levels within the institute. Her research interests are broad including health care financing, health insurance, health policy, health systems, preferences and decision-making, cost-benefit analysis, stated preferences, econometrics, cross-country comparative analysis, policy assessment and health system performance.

Still, her main research focus has been formal and informal patient payments in Central and Eastern European countries and on this topic she has been the coordinator of an international FP7 project funded by the European Commission. Her research portfolio also includes participation in two new projects funded by the European Commission, in addition to several small-scale research projects focused on developing countries. In 2016, she has received AXA Award for her overall research achievements.

Her research has resulted in more than 80 international publications in academic peer-review journals and a similar amount of national publications. Milena has published in prestigious journals such as *Social Science and Medicine*, *European Journal of Health Economics*, *Health Policy and Planning*, *PloS One*, *Health Expectations*. She is also a section editor in *BMC Health Services Research*.
